## **Vacancy Advertisement**

Applications are invited from qualified candidates who wish to be considered for employment as “**REGISTRAR**” on a **contract basis** in the Allied Health Professionals Council of Mauritius.

### **1. Qualifications:**

**A.** Candidates should be an allied health professional as per the First Schedule of the AHPC Act 2017 and having at least 5 years’ experience as an allied health professional in their respective field.

**B.** Candidates should:

- (a) possess strong interpersonal and communication skills;
- (b) have the ability to lead a team of officers; and
- (c) be conversant with the use of Information and Communication Technologies (ICT).
